DAC XI Resolution No. 02, Series of 2008

Endorsing the Approval of the Bureau of Jail Management and Penology (BJMP) XI's Proposed List of Priority Programs, Activities and Projects (PAPs) for the FY 2009 Davao Region Annual Investment Program (AIP) with the Recommendation that Specific PAPs be Included Therein

Whereas, The FY 2009 Annual Investment Program (AIP) is intended to serve as the validated annual slice of Davao Regional Development Investment Program (RDIP), 2005-2010;

Whereas, The FY 2009 AIP will serve as basis in the review of the FY 2009 budget proposals of the regional line agencies;

Whereas, The proposed list of FY 2009 programs, activities and projects (PAPs) of the Bureau of Jail Management and Penology (BJMP) XI was presented to this Committee for its validation and endorsement in view of the emerging priorities of the region and its constituent local government units (LGUs), and the new policy directions set by the national government;

Whereas, This Committee generally finds the list consistent with the thrusts of the Davao Regional Development Plan (DRDP), 2004-2010, particularly in addressing the development challenge of improving the living conditions of prison inmates;

Whereas, The said list also addresses specific sectoral gaps, particularly in the following:

- a. It addresses concerns about improving living conditions in rehabilitation cells.
- b. It responds to the problem of inadequacy of rehabilitation facilities in the Davao Region;

Whereas, While the list has been determined to have addressed the foregoing concerns, this Committee also finds the need and is therefore recommending the inclusion in such list PAPs also addressing:

- a. The preparation of inmates for eventual reintegration into the society.
- b. The transfer of the BJMP building in Panabo City to a new site; now, therefore, be it


1. A PAP proposal for the preparation of inmates for eventual reintegration into the society.
