EDC XI Resolution No. 01 Series of 2010

A Resolution Endorsing to the Regional Development Council XI the Establishment of the Proposed Port Zone Delineation of Maco Port, Phase I for Presidential Declaration

Whereas, the Maco Port Development Project was included in the Davao Integrated Development Plan (DIDP) being identified as an industrial port of Compostela Valley to serve the province and neighboring areas;

Whereas, the Sangguniang Bayan of the Municipality of Maco passed Resolution No. 16, Series of 2010, Endorsing the Proposed Port Zone Delineation of Maco Port, Phase I to Her Excellency President Gloria Macapagal Arroyo through the Port District Manager of the Philippine Port Authority, Davao City for Presidential Declaration as Maco Port Zone;

Whereas, Executive Order 410 signed by President Corazon C. Aquino on July 3, 1990 provides, among others, that the Philippine Ports Authority (PPA) shall consult the concerned Regional Development Council (RDC) before conducting the detailed surveys on the subject area for port zone delineation;

Whereas, said EO 410 enumerated the requirements to be complied with by the PPA, including the documents to be submitted to the concerned RDC, for its review and endorsement of the application to the President;

Whereas, the Committee finds the proposed Maco port zone delineation vital to the development, not only of the Municipality of Maco and the Province of Compostela Valley, but the entire Davao Region as well, thus, it has passed Resolution No. 24 series of 2008, endorsing said proposal subject to the compliance of its recommendations, including the submission of all documents as required under EO 410;

Whereas, all recommendations of this Committee have been complied with by all concerned, including the submission of all documents required under EO 410; now, therefore, be it

Resolved, as it is hereby resolved, that this Committee endorse to the RDC XI the proposed port zone delineation of Maco Port, Phase I for Presidential Declaration.

Resolved further, that copies of this resolution be forwarded to Office of the President, the Municipal Government of Maco, the Provincial Government of Compostela Valley and the Philippine Ports Authority, for information and appropriate action.
