**EDC XI Resolution No. 10, Series of 2010**

**Recommending to the RDC XI the Approval of the Validated List of Priority Programs, Activities and Projects (PAPs) of the Department of Trade and Industry (DTI) XI in the Amount of Php 33,900,000.00 for Inclusion in the CY 2011 Annual Investment Program (AIP) of Davao Region**

*Whereas*, the Department of Trade and Industry (DTI) XI submitted to this Committee a list of proposed programs, activities and projects (PAPs) under its CY 2011 Annual Investment Program (AIP) in the amount of Php 33,900,000.00 for review and endorsement to the Regional Development Council (RDC) XI pursuant to RDC XI Resolution No. 02, Series of 2010;

*Whereas*, this Committee reviewed the proposed CY 2011 of DTI XI and noted that it covers PAPs that provide greater opportunities for local industries to expand their markets outside the country and also allow the identification of local industries for development;

*Whereas*, this Committee, however, also noted that there is a need for DTI XI to specify the target number and type of outputs/beneficiaries and specific location of some of its proposed PAPs, in line with the objective of resource allocation efficiency, as well as the promotion of gender and development;

*Whereas*, DTI XI is also enjoined to consider other PAPs that will provide market opportunities for local industries beyond the Brunei Darussalam Indonesia Malaysia Philippines-East ASEAN Growth Area (BIMP-EAGA) and the East Asia, such as Australia and New Zealand;

*Whereas*, this Committee, nonetheless, found the proposed CY 2011 AIP of DTI XI generally supportive of the development thrusts and emerging directions of Davao Region, particularly of its economic sector; *now, therefore, be it*

*Resolved, as it is hereby resolved*, that this Committee recommend to the Regional Development Council XI the approval of the validated list of priority programs, activities and projects (PAPs) of the Department of Trade and Industry (DTI) XI in the amount of Php 33,900,000.00 for inclusion in the CY 2011 Annual Investment Program (AIP) of Davao Region, subject to the compliance of this Committee's recommendations.
