INFRASTRUCTURE DEVELOPMENT COMMITTEE XI

IDC XI Resolution No. 01, Series of 2007

Recommending to the RDC XI the endorsement of the Philippine-Japan Friendship Highway Rehabilitation Project, Phase 3 (Carmen-Davao City Section) and Providing the Required Maintenance Activities Thereof Including those Projects Undertaken under Phase 1 and 2

Whereas, The Department of Public Works and Highways – Project Management Office-Feasibility Study (DPWH-PMO-FS) submitted for RDC XI endorsement the proposed Phase 3 (Carmen-Davao City Section) of the Philippine-Japan Friendship Highway Rehabilitation Project and the provision of required maintenance activities including those projects implemented under Phase 1 and 2;

Whereas, The Department of Public Works and Highways committed to submit the following requirements based on the findings and recommendations of the Secretariat:

1. Logical Framework of the Project
2. Endorsement of the Project by the Provincial and City Development Councils of Davao del Norte and Davao City, respectively
3. Measures and innovative strategies that will enhance supervision during implementation of the Project
4. Road Safety Audit Report
5. Traffic safety and efficiency assessment of the existing Buhangin Underpass
6. Cost effective design alternatives on the intended improvement at Pangi Bridge and Davao River Bridge
7. Construction Waste Disposal Plan, Traffic Management Plan, Dust and Noise Pollution Control Plan, Worker Safety and Wage Plan and Resettlement Plan

Whereas, The Infrastructure Development Committee (IDC) XI finds the proposed project consistent with the thrusts and priorities of the region as spelled out in the Davao Region Development Plan, 2004-2010 to strengthen inter-regional linkages and enhance mobility of people and the flow of goods and services; now therefore be it



Resolved, as it is hereby resolved, That the IDC XI recommend to the Regional Development Council (RDC) XI the endorsement of the Philippine-Japan Friendship Highway Rehabilitation Project, Phase 3 (Carmen-Davao City Section) and the provision of the required maintenance activities including those implemented under Phase 1 and 2.


