*Whereas*, the 2010 AIP for the Infrastructure Sector will serve as basis in the review of the CY 2010 budget proposals of the infrastructure line agencies;

*Whereas*, the concerned regional line agencies and local government units (LGUs) in Davao Region validated their respective PAPs to become more responsive to and consistent with the priorities of the region;

*Whereas*, the Infrastructure Development Committee XI generally finds the list of programs, activities and projects contained in the 2010 AIP for the Infrastructure Sector consistent with the priorities of the region; now, therefore, be it
