### **IDC XI Resolution No. 06, Series of 2010**

#### **Recommending to RDC XI to Endorse the Six (6) Priority Infrastructure Project of Compostela Valley for National Funding**

*Whereas*, the Provincial Government of Compostela Valley has identified the following infrastructure projects, three (3) of which have corresponding costs, namely;

1. Construction of Nabunturan-Maragusan National Road (Php724 Million)
2. Construction of Mawab Alternate RCDG bridge (Php 20 Million)
3. Desilting of Kingking River of Pantukan (Php 100 Million )
4. Rechanneling of Some Sections of the Batutu River System (traversing the municipalities of New Bataan and Montevista)
5. Desilting of Naboc River of Monkayo
6. Desilting of Manat River (traversing the municipalities of Nabunturan and Montevista)

*Whereas*, given enormous costs of the foregoing proposed projects and the financial constraints of the province, the Provincial Development Council (PDC) of Compostela Valley through its Resolution Numbers 1 to 6, Series of 2010, has endorsed these projects for National Government funding;

*Whereas*, the project proposals were submitted to this Committee for evaluation and endorsement;

*Whereas*, this Committee finds the abovementioned six (6) priority infrastructure projects of Compostela Valley supportive of the achievement of the Davao Region's objective to provide adequate and modern infrastructure and to reduce disaster risks; *now, therefore, be it*

*Resolved, as it is hereby resolved*, that this Committee recommend to RDC XI to endorse the six (6) infrastructure projects of Compostela Valley for National Government funding.

*Resolved further*, that a copy of this resolution be furnished to RDC XI and the Provincial Government of Compostela Valley for information and appropriate action.
