MFC XI Resolution No. 06, Series of 2009

Requesting RDC XI to Enjoin the Bureau of Internal Revenue (BIR) Revenue Region 19 to Conduct Massive Information Campaign on its Performance Benchmarking Method (PBM) in Coordination with Partner Agencies and Local Government Units (LGUs) in Davao Region

Whereas, the Bureau of Internal Revenue (BIR) is currently adopting the Performance Benchmarking Method (PBM) as a tool in tax collection;

Whereas, despite the success of PBM's implementation in Davao Region as claimed by BIR Revenue Region 19, unfavorable reaction to the tool from the region's business sector with the Davao City Chamber of Commerce and Industry, Inc. (DCCCII) at the forefront, was brought to the attention of this Committee;

Whereas, a dialogue between BIR Branch 19 and DCCCII was encouraged by this Committee and RDC XI to explore the resolution of the matter;

Whereas, a report on the aforementioned dialogue has been presented by DCCCII and BIR Revenue Region 19 before this Committee;

Whereas, in the discussion following the report, members from the Committee, particularly DTI XI and DOLE XI, urged BIR Revenue Region 19 to coordinate with partner agencies and local government units (LGUs) in Davao Region which conduct fora involving the private sector, to advocate the tool among taxpayers;

Whereas, this Committee agrees with the suggestions for the BIR Revenue Region 19 to take advantage of the support of the business sector in advocating the tool to allay the apprehensions of the public about the tool; *now, therefore, be it*

Resolved, as it is hereby resolved, that this Committee request the Regional Development Council XI to request the Bureau of Internal Revenue (BIR) Revenue Region 19 to conduct massive information campaign on its Performance Benchmarking Method (PBM) in coordination with partner agencies and local government units (LGUs) in Davao Region.

Resolved further, that a copy of this resolution be forwarded to the Regional Development Council XI for its information and consideration.
