**Recommending to RDC XI to Endorse the TESDA XI Project Proposal Entitled Establishment and Construction of the Korean Language Center and Tae Kwon Do Center Sports Gymnasium for Funding Assistance by the Korean International Cooperation Agency (KOICA)**

*Whereas*, the Technical Education and Skills Development Authority (TESDA) XI, Regional Training Center/Korea Philippines Vocational Training Center-Davao (RTC/KPVTC Davao) submitted the proposal entitled *“The Establishment and Construction of the Korean Language Center and Tae Kwon Do Center Sports Gymnasium”* for funding assistance by the Korean International Cooperation Agency (KOICA);
